# 2022 Great Plains 6ft No-Till Drill Lease Agreement (Model 605NT Serial Number: 0975-03)

#### **Terms of Lease**

<b>Lease Period:</b> This lease begins on	( <b>date</b> ) and ends on	(date). If
additional time is needed, the Producer must co	ontact the District as soon as an	extension is needed
to ensure the drill is not scheduled with some	one else. Check-out and check-	in shall be between
8:00 AM and 5:00 PM on weekdays unless oth	nerwise agreed upon.	

**Transportation:** The District will transport the No-Till Drill to and from the Producer's premises unless otherwise approved by the District for the Producer to transport. The Producer must provide a **tractor with at least 80 horsepower** to operate the drill.

**Restrictions:** The No-Till Drill **shall not be sublet** or transferred without written consent from the District. The drill **must remain within Fremont County**, with additional charges if used outside the LWRCD boundary.

#### **Lease Pricing**

• **In-District Rate:** \$15.00 per acre

• Out-of-District Rate: \$18.00 per acre

• **Deposit:** \$100.00, due at or before delivery.

- **Final bill:** The producer will receive an invoice and pay for the use of the drill after the use is complete, along with sales tax, minus the \$100.00 deposit.
- Mileage Fee: \$1.00 per mile for rentals beyond 40 miles one way from the LWRCD office. Example: A producer rents the drill 60 miles from the LWRCD office, he incurs a \$40 trip charge (\$20 for delivery, \$20 for pickup).
- Cleaning Fee: \$100.00 if the drill is not properly cleaned, including vacuuming or using compressed air for seed boxes and hoses. The exterior may be pressure washed. District personnel will inspect the drill to determine if the cleaning fee applies.

### **Producer Responsibilities**

**Pre & Post-Use Inspection:** The Producer and District personnel will review and initial the attached Equipment Checklist before and after use.

**Liability:** The Producer is responsible for any **loss, theft, damage, or destruction** of the drill from the time it is checked out until it is checked back in with the District.

**Proper Use:** The drill must be used responsibly on appropriate fields and <u>adjusted for rough conditions</u>. After use, the Producer will make sure the No-Till Drill is in the same or better condition than it was when received. Normal wear from responsible use is expected.

The Producer will refer to the operator's manual (located on the front of the drill) for maximum drilling and transport speed. Lubrication requirements are listed in the 605NT Great Plains No-Till Drill Operator's Manual. The District reserves the right to charge the Producer for any equipment returned damaged, uncleaned, or without proper maintenance.

#### **Traveling and Engaging Procedures**

The Producer will refer to the operator's manual (located on the front of the drill) for maximum drilling and transport speed.

- 1. Cylinder Locks: Place cylinder locks on both hydraulic cylinders before transporting.
- **2. Drive Lock-Out:** Ensure the drive lock-out hub is <u>disengaged</u> on both sides while transporting.
- 3. Roadway Travel:
  - o Flashing hazard lights must be used at all times.
  - Maintain a speed of 30 MPH or less.
- 4. At the Field:
  - o Remove cylinder locks and store them on the hub above the wheels.
  - o Turn the drive lock-out into the drive lock-in position.

#### **Notification**

The Producer must immediately notify the Lower Wind River Conservation District at (307) 463-0636 if the drill requires maintenance or repairs.

#### **Disclaimer of Warranty**

The District provides **no express or implied warranties**, including equipment condition or fitness for a specific purpose. Equipment defects or unfitness **do not relieve** the Producer of rental payment obligations.

#### **Indemnity**

The Producer shall defend, indemnify, and hold harmless the District, including its officers, employees, board members, and agents, from any and all claims, actions, suits, proceedings, court awards, costs, expenses, damages, and liabilities—including attorney fees—arising from or related to the equipment or its lease. This includes, but is not limited to, the equipment's manufacture, selection, delivery, leasing, renting, control, possession, use, operation, maintenance, or return. Additionally, the Producer shall indemnify and hold harmless the District, its officers, employees, board members, and agents from any loss or damage to the equipment during the rental period. This indemnity clause also extends to all liability for injury, disability, or death of workers and other individuals resulting from the operation, use, control, handling, or transportation of the equipment during the rental period.

#### **Insurance**

The Producer shall maintain insurance for the full replacement value of the equipment \$10,000.00 and for any liability arising from the Producer's use and rental of the No-Till Drill. The Producer shall provide proof of insurance covering the rental of the No-Till Drill before receiving the drill.
